Paul Dragon, Champlain Valley Office of Economic Opportunity

- CVOEO, working with City of Burl, was able to secure funding from CHIC Emerging Needs
 Grant; supporting up to 7 families to stay at Harbor Place. Funding is flexible so could
 also be used at the end of the season (after AWC). Five HHs have been placed at HP
 under this temporary program.
- Prioritizing unsheltered families
- CRC renovations have been shifted to 4/15/2025; actively searching for alternative location to serve food/resources
- Champ Inn seasonal beds hope to be open by Jan 1

Kerri Duquette-Hoffman, VT Agency of Human Services Williston Family Shelter Update:

- Seven-family capacity at the new Williston Shelter; six families now
- Message has been sent to CCHA listserv with instructions to apply
- Waterbury shelter has 10 HH capacity and has one family now
- If family has not accessed motel stay, they will be referred to the shelter first in their district as long as there is shelter capacity within their home county
- Criminal background checks are required; pets not allowed
 - Triggers for criminal background checks are not available; policy team reached out to local shelters to understand
- Kerri is the person who is coordinating services for each of the families; please reach out to Kerri if you are able to provide youth/family services

Extreme Cold Shelter

- AWC includes only categorical eligibility (as has for the last 16 years)
- We currently do not have operator for the Extreme Cold Shelter in Chittenden County
- State can assist with MRC and others but operator is needed to take lead
- Extreme Cold Shelters operate for 2-5 days, funding support from OEO
- Miller Center in Burlington is designated location
- VT Emergency Management determines when these extreme weather shelters will open

There are openings in Lund's Residential Treatment Program; please make referrals for people who may be a good fit. Do not allow people who are actively using but work very closely with in-patient treatment programs so people can transition from in-patient. Average stay is 12-18 months. Case manager works to ensure they are on housing lists to be able to transition to permanent housing from residential treatment program. Participant staying in residential treatment do not meet HUD homeless criteria until they are within two weeks of discharge.

Do not have zero tolerance substance policy; case-by-case basis.

Home visiting can be available for people who are homeless as well; working to support families at the Williston shelter; PAT is just coming on-board now so there are no families enrolled but will be building caseload soon. Referrals can be submitted via CIS as well but PAT is not connected to CIS; referrals can also be

11. Prevention Funding

- 1. OEO was able to identity about \$800k additional funds for HOP financial assistance (typically used for prevention); OEO will do an analysis of spending after Q2 and may reallocate based on utilization. These are one-time funds.
- 2. Travis: new funding brought us to 50% of budget from last year; no changes to criteria right now but may need to discuss expanding this and adjusting criteria.
- 3. VSHA has funding for eviction prevention beginning next week: they have held two trainings around eligibility criteria. Applications can be submitted online. Training announcement and eligibility criteria will be sent out to CCHA listserv.
